## TREATY AGREEMENT

This Treaty is entered into on the 28th day of May, 2026 Between the Nation States:

A) **Majagi Larrakia 1600 Countries Societatum of TIBNLA**  
Governance Office 35 Howley Crescent Anula Larrakia NT, 0812

and

B) **Nations of the Pintupi Wati Tjuta Tjungarinyi**  
Care of Kintore Store NT, 0872.

and

C) **The Islamic Royal Sultanate of Simunul**  
National Ministerial Customary Hall  
Rajahnate Principality House of Tupas Humabon  
Bellavista, Santiago, 4017 Gen. Trias, Cavite, PHILIPPINES



This official document sets out the terms and conditions of this Treaty agreement in compliance with Article 1, 3.1 and 7 of the Vienna Convention for Treaties between Nation States.

### Terms of Agreement.

1. Both Nations agree to conduct all exchanges under friendly relations with utmost mutual respect for their cultures, apical bloodline hierarchies, family histories, religions and belief systems, commerce, business activities, trade and barter arrangements, and goods and services exchange.
2. Both Nations agree to adhere to their foundational rules-based systems of cultural lore for their land and sea country with respect for the principle of First in Time Best at Lore/Law, in fulfillment of full terms and conditions of this Treaty that reflect critical elements of sacred lore in their Treaties, Constitutions, Charters, Conventions, Declarations, Letters Patent, and Governance by rules-based systems of Lores/Laws.
3. Both Nations agree to assist each other's growth in and through international relations in creating trade and barter opportunities through exchange for goods and services, through cultural exchange, education and training, the arts, tourism, resources and development opportunities, and arrangements they agree to from time to time.
4. This Treaty agreement can be altered, changed, amended, or cancelled, at any time with 30-days' written notice to the other party.
5. This agreement is signed by the representatives from the participating Nation States and constitutes authentication for this Treaty by way of international rule-of-law, including the Law of Nations, and by way of each Nation's systems of rules-based Laws/Lores for their lands and seas territories.

**Treaty for Cultural Recognition and Civil-Social-Economic-Environmental Development between the Nation State of Majagi Larrakia 1600 Countries Societatum of TIBNLA and the Nations of the Pintupi Wati Tjuta Tjungarinyi and THE SULTANATE PRINCIPALITY OF SIMUNUL**

**Preamble**

Recognizing the shared desire to foster mutual respect, cultural understanding, and socio-economic prosperity.

Acknowledging the unique cultural heritage and economic potential of both nations.

Committed to sustainable development and equitable cooperation.

Country A) Majagi Larrakia 1600 Countries Societatum of TIBNLA, and

Country B) Nations of the Pintupi Wati Tjuta Tjungarinyi

Country C) THE SULTANATE PRINCIPALITY OF SIMUNUL — agrees as follows:

**Article 1: Objectives**

1.1 Promote mutual recognition and appreciation of cultural identities.

1.2 Enhance socio-economic cooperation through trade, investment, and social Programs.

1.3 Foster sustainable development aligned with global standards.

**Article 2: Cultural Recognition**

2.1 Both Parties shall:

a. Organize calendric cultural festivals showcasing each other's traditions, arts, and cuisine.

b. Establish exchange programs for students, artists, and cultural practitioners.

c. Protect cultural heritage sites and intellectual property, respecting international conventions.

2.2 A joint commission for cultures shall be formed to oversee initiatives, meeting biannually.

**Article 3: Civil-Social-Economic-Environmental Development**

3.1 Trade and Investment:

a. Eliminate trade barriers to facilitate commerce.

b. Encourage joint ventures in sectors of interest such as [e.g., technology, agriculture].

3.2 Social Development:

a. Collaborate on educational programs, including annualized scholarships for students.

b. Share expertise in full-spectrum healthcare, focusing on [e.g., telemedicine, public health].

3.3 Sustainability: Promote green technology and infrastructure projects with shared funding.

**Article 4: Implementation and Funding**

4.1 Bilateral Development Fund to be established, with equal contributions from both Parties.

4.2 Annual progress reports shall be published, detailing outcomes and challenges.

4.3 A Joint Monitoring Committee shall evaluate progress using agreed indicators.

**Article 5: Dispute Resolution**

5.1 Dispute resolution shall be achieved through dialogue with the Joint Monitoring Committee.

5.2 If unresolved, disputes shall be referred to [mediation by the IGO Global South Group].

**Article 6: Duration and Termination**

6.1 This Treaty shall enter into force upon ratification and remain valid until terminated.

6.2 Either Party can terminate agreement/s with 30 days written notice, subject to obligations.



**Article 7: Amendments**

7.1 Amendments require 30 days written notice mutual consent and ratification by both Parties.

**Article 8: Final Provisions**

8.1 This Treaty is signed in duplicate by:




